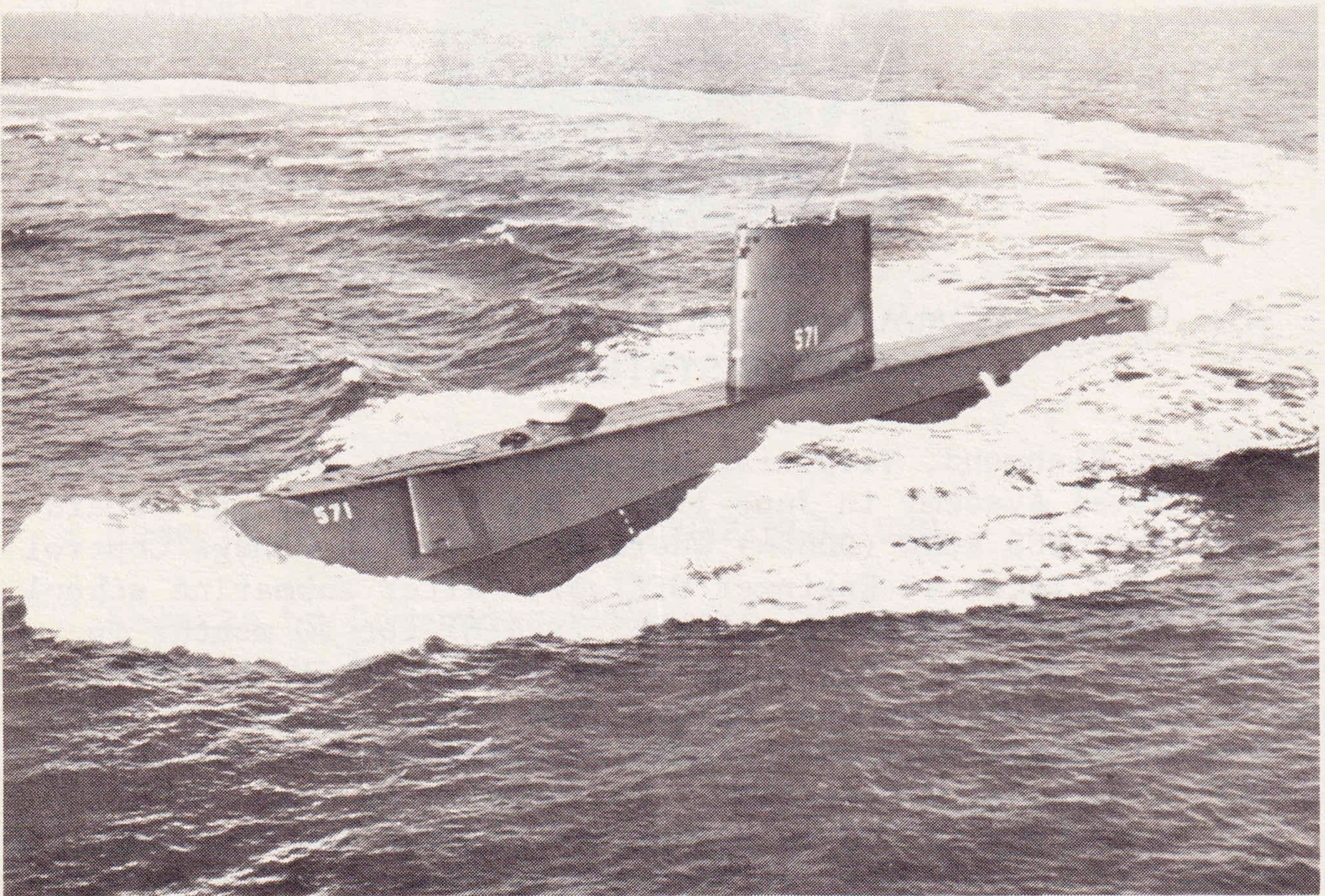


CHANGE OF COMMAND

**COMMANDER NORMAN E. GRIGGS
UNITED STATES NAVY**

A native of Richmond, Virginia, Commander GRIGGS graduated from the U.S. Naval Academy in June 1953. His first duty was aboard the destroyer USS ROWE (DD654) where he served as Damage Control Assistant and later as Engineer Officer. After submarine school in 1955, he was assigned to USS TIRU (SS416) for 30 months in Pearl Harbor, Hawaii. Following Nuclear Power Training at New London, Connecticut and West Milton, New York, Commander GRIGGS was ordered as a member of the commissioning crew of USS SCORPION (SSN589) at Groton, Connecticut. For service on board SCORPION in 1962, Commander GRIGGS is authorized to wear the Navy Unit Commendation. In August 1963, he reported as Executive Officer of USS ROBERT E. LEE (SSBN601) Blue Crew. From 1965 to 1967 he attended the Naval Postgraduate School at Monterey, California, where he received a master's degree in Operations Research. He relieved as Commanding Officer, USS NAUTILUS (SSN571) in April 1967. Commander GRIGGS is married to the former Mary Lou Puller of Richmond, Virginia. They have two daughters and reside in Groton, Connecticut.

COMMANDER DAVID W. COCKFIELD
UNITED STATES NAVY

Commander COCKFIELD was born in Toledo, Ohio on January 31, 1932, the son of Mr. and Mrs. Edward G. COCKFIELD. After graduating from West High School in Columbus, Ohio, he spent a year at Ohio State University before accepting a NROTC appointment to the U.S. Naval Academy with the class of 1955. His first duty was aboard the USS ROBERT K. HUNTINGTON (DD781) where he served as Gunnery Officer. Upon completion of Submarine School, in December 1958, he reported to the USS VOLADOR (SS490) where he served as Weapons Officer and Operations Officer. In January, 1960, Commander COCKFIELD commenced a year of theoretical and practical Nuclear Power Training at New London, Connecticut and Arco, Idaho. The following year he served as an instructor at the Naval Nuclear Power School in Mare Island, California. From February 1962, until May 1965 Commander COCKFIELD was a member of the commissioning crew of USS POLLACK (SSN603). He then served as Engineer Officer aboard USS THOMAS A. EDISON (SSBN610) Gold Crew. In April 1966 Commander COCKFIELD began two years as Technical Assistant for Training at Naval Reactors Division, Bureau of Ships, in Washington, D.C. From July 1968 until September 1969 he served as Executive Officer of USS LAFAYETTE (SSBN616) Blue Crew after which he underwent Prospective Commanding Officer Training at the Naval Reactor Division. Commander COCKFIELD is married to the former Mary Winifred Davis of Pensacola, Florida. The COCKFIELDS have five children, and reside in Arlington, Virginia.
