Penny Durenberger, a Minneapolis native and a graduate of the University of Minnesota, has spent most of her adult life in public service.

She was an aide to Wendell Anderson when he was Governor of Minnesota. Prior to her husband's election to the Senate in 1978, she was a member of the governing boards of the Minnesota Conservation Foundation and the state's Zoological Society. She also was active in the Minneapolis Children's Center. In addition, she chaired the Advisory Committee on Lake Water Quality.

The Durenbergers have four sons - Charles, David, Michael, and Daniel.





Minneapolis, located with its "twin" city Saint Paul, at the head of the Mississippi River, is a thriving industrial, financial, and cultural center. Founded in 1867, MINNEAPOLIS boasts a population of a half million. Its name is a combination of "Minnie" the Sioux Indian word for water and "polis" the Greek work for city.

Set among a series of picturesque lakes and ponds and twice named "All American City," Minneapolis is headquarters for several of the nation's largest high technology and food industries.

The city's skyline is dominated by the gleaming 57 story Investor Diversified Services (IDS) Tower, the tallest building between Chicago and San Francisco. Other significant structures include the 50 story City Center and the 65,000 seat Hubert H. Humphrey Metrodome, home of the Minnesota Vikings and Twins, and the Metropolitan Sports Center, home of the Minnesota North Stars.

The downtown area features the Nicollet Mall, a walkway flanked by fountains, greenery, shops and stores, and a Skyway system, a series of glass-enclosed walkways at the second story level connecting 13 blocks of shops and entertainment.

The city's park system 4,100 acres of rolling woodland dotted with 22 lakes, provides for year round recreational activities.

For higher education, the city has the University of Minnesota, Augsburg College, and the Minneapolis School of Arts.

Topping the city's cultural list are its symphony orchestra, which ranks among the country's top five, several museums, and a leading resident repertory theater.



Saint Paul, Minnesota's capitol city and the other half of the state's famous "twin" cities, evolved from an early fur-trading outpost into what is today a vibrant livestock, transportation and industrial center.

Among its most significant products are automobiles, computers, guidance systems, and plastics. The Mississippi River, which winds through the city along with modern highways, has ensured its continued importance in commerce.

Incorporated in 1849 and named for the patron saint of a crusading priest, Father Lucien Galtier, the city has capitol building that has one of the largest unsupported domes in the country. The State Office Building, the State Historical Society Building (museum of historical artifacts), the Department of Highways Central Office Building, the Centennial Building, and the State Veterans Service Building round out the capitol building group.

Dominating the City Hall and Courthouse concourse is the "Indian God of Peace", an onyx statue 36 feet high.

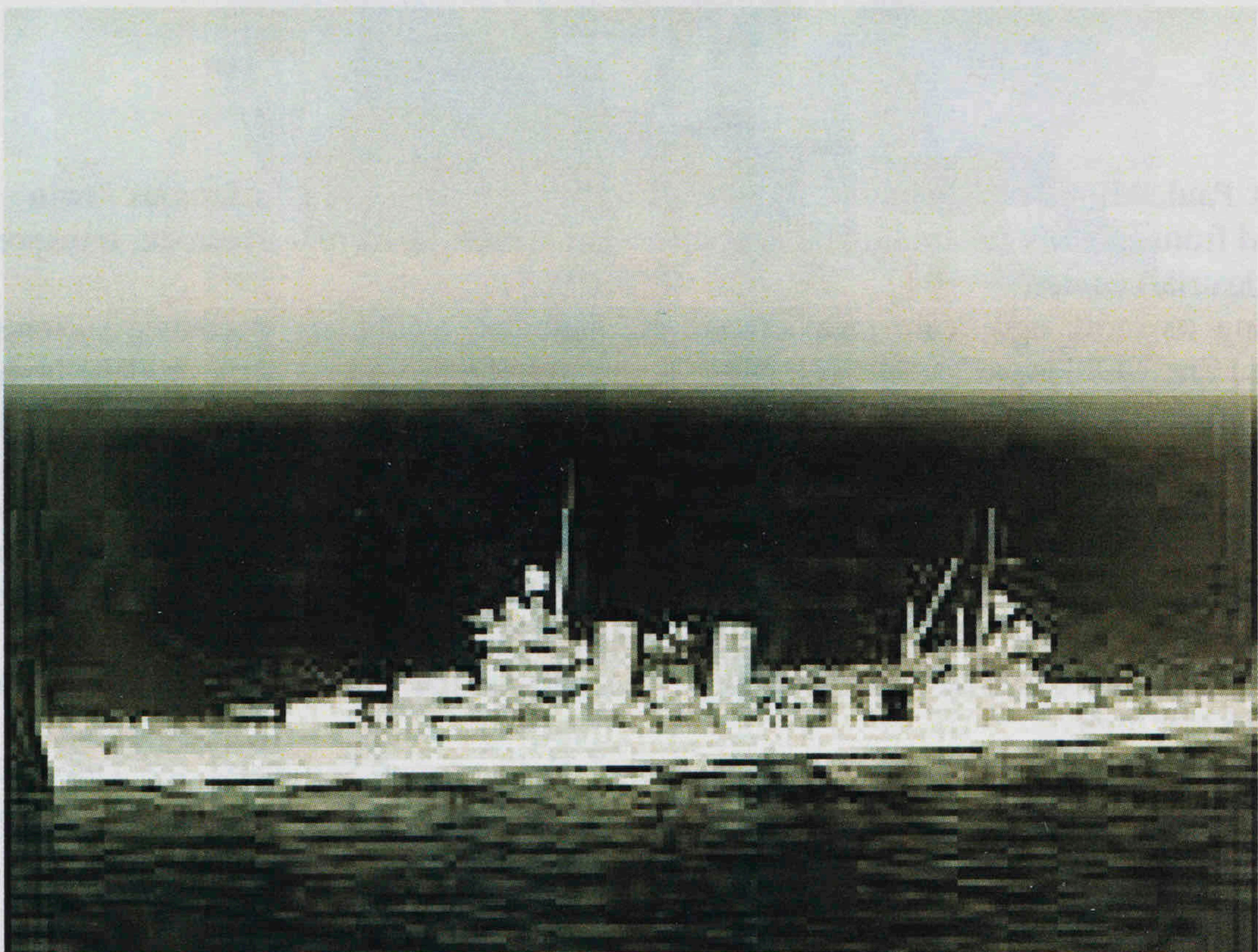
Higher educational institutions include Bethel College and Seminary, the University of Minnesota's College of Agriculture, Colleges of St. Catherine and St. Thomas, Concordia and Macalester Colleges, Minnesota Metropolitan State College, and Hamline University.

Saint Paul affords its 270,000 residents excellent recreational opportunities with 30 lakes nearby. There are also 92 parks. Several of the lakes afford public beaches and other water sport facilities.

HISTORY OF SHIPS NAMED MINNEAPOLIS

The first, MINNEAPOLIS (S-13), was commissioned in Philadelphia in 1894. She served in the North Atlantic Squadron, operating in the Mediterranean. She visited Cronstadt, Russia in 1895 as a flagship of Rear Admiral T.O. Selfridge, representing the U.S at the coronation of Czar Nicholas II. The MINNEAPOLIS performed scouting duties during the Spanish American War, and was decommissioned. She was recommissioned in 1903 and assigned to a special service squadron to make astronomical and other scientific observations off the coast of Spain and Africa. She was at Annapolis, Maryland in 1906 for ceremonies commemorating the arrival of the body of John Paul Jones. Decommissioned again in 1906, she was recommissioned in 1917 and operated along the Atlantic coast and as escort ship during World War I.

The second MINNEAPOLIS (CA-36) was a heavy cruiser commissioned in 1934. Arriving at Pearl Harbor in 1940, she was at sea for gunnery practice when Pearl Harbor was attacked. The MINNEAPOLIS participated in the Battle of Coral Sea in 1942 and the Battle of Midway in 1942, the landings at the Philippines, Bataan, and Corregidor. She was decommissioned in 1947. The MINNEAPOLIS (CA-36) earned 16 engagement stars for World War II service.



HISTORY OF SHIPS NAMED SAINT PAUL

The first SAINT PAUL was a steel passenger liner chartered for U.S. Naval services as an auxiliary cruiser in 1898 during the Spanish American War. She was decommissioned the same year and returned to her owner. The SAINT PAUL was again taken over by the Navy in 1917 and used as a transport ship during World War I. She was returned to her owner in 1919 and scrapped in 1923.

The second SAINT PAUL (CA-73) was a heavy cruiser, built by Bethlehem Steel in Quincy, Mass. and commissioned in 1945. She operated as a screen for carriers as they delivered heavy air strikes on Japan. The SAINT PAUL was later involved in the Korean Conflict. In July 1953, the SAINT PAUL had the distinction of firing the last round at sea in the war. She saw action during the Vietnam War and was decommissioned in 1971. The SAINT PAUL (CA-73) earned one engagement star for World War II service, eight for Korean War Service and an additional eight for the Vietnam War.





Vice Admiral John Donnelly United States Navy

Vice Admiral John Donnelly, a native of Groton, CT and second-generation submarine officer, began his Naval career at the U.S. Naval Academy, graduating with distinction in 1975 with a bachelor of science degree in physics. Early tours include assignments on board USS TAUTOG (SSN 639) as a division officer and Weapons Officer; Engineer Officer on USS MEMPHIS (SSN 691); physics instructor at the U.S. Naval Academy; Executive Officer on USS SIMON BOLIVAR (SSBN 641); and Assistant for Undersea Warfare and Strategic Issues for the Chief of Naval Operations Executive Panel staff (OP-00K).

Vice Admiral Donnelly's first command assignment was as Commanding Officer, USS HYMAN G. RICKOVER (SSN 709) from November 1991 to December 1994.

Following his command assignment, he served on the OPNAV staff working for the Deputy Chief of Naval Operations for Submarine Warfare Requirements as Head of the Submarine Acquisition Branch (N872C) and later as the Assistant for Plans and Liaison (N87C). Vice Admiral Donnelly next served as Commanding Officer, USS McKee (AS 41), a submarine tender homeported in San Diego, from May 1997 to July 1998.

His next assignment was in Yokosuka, Japan where he served as Chief of Staff for Commander SEVENTH Fleet from July 1998 to July 2000. Vice Admiral Donnelly was selected to flag rank near the end of that tour. His first flag officer assignment was as Director of Combat Plans (J5A) and later as Deputy Director for Operations and Logistics (J3/4A) at the United States Strategic Command from July 2000 to May 2003.

Vice Admiral Donnelly was then assigned as Commander Submarine Group SEVEN, Commander Task Force SEVEN FOUR, and Commander Task Force FIVE FOUR headquartered in Yokosuka, Japan from July 2003 to June 2004 where he was selected to two star rank.

From June 2004 to December 2006, he served in Pearl Harbor as Deputy Commander and Chief of Staff, U.S. Pacific Fleet. In February 2007, Vice Admiral. Donnelly assumed command as the Commander, Submarine Force, where he is responsible for all U.S. submarines and their crews and for all foreign submarine operations when assigned to NATO.

Vice Admiral Donnelly received a Master of Science Degree in Engineering Acoustics from the Naval Postgraduate School in 1976 and he attended the MIT Seminar XXI on Foreign Politics, International Relations and National Interest from September 1996 to June 1997.

Vice Admiral Donnelly's personal decorations include the Distinguished Service Medal, Defense Superior Service Medal, Legion of Merit (four awards), Meritorious Service Medal (two awards), Navy Commendation Medal (six awards), Navy Achievement Medal and various unit and campaign awards.



Captain David Kriete United States Navy

Captain Dave Kriete is a native of Brooklyn, New York and a 1984 graduate of the United States Naval Academy where he majored in general engineering. Following commissioning he completed nuclear power training at Orlando, Florida and Ballston Spa, New York.

Captain Kriete's first shipboard assignment was USS FINBACK (SSN 670) where he served as Main Propulsion Assistant and then Communications Officer from March 1986 to June 1989 while deploying twice to the North Atlantic. He then served on the Staff of Commander, Submarine Force U.S. Atlantic Fleet from June 1989 to July 1991 as the Assistant Force Special Operations Officer.

During his next sea tour Captain Kriete served as Engineer Officer and then Navigator/Operations Officer and Weapons Officer onboard USS FLYING FISH (SSN 673) from February 1992 to July 1995 while deploying to the North Atlantic, the Mediterranean and the Caribbean. He then served on the Staff of Commander in Chief, U.S. Atlantic Fleet as a member of the Nuclear Propulsion Examining Board from July 1995 to July 1997.

Captain Kriete next served as Executive Officer onboard USS KENTUCKY (SSBN 737) (GOLD) from December 1997 to November 1999 completing three strategic deterrent patrols. He then served in Washington D.C. on the staff of the Chairman of the Joint Chiefs of Staff as an Action Officer in the Nuclear Operations Division from November 1999 to January 2002.

Captain Kriete commanded USS RHODE ISLAND (SSBN 740) (BLUE) from September 2002 to March 2005, completing four strategic deterrent patrols, including a rare deployment to the Mediterranean Sea in 2003. During his tour, RHODE ISLAND BLUE received the COMSUBRON SIXTEEN Battle Efficiency Award for 2003, 2004, and 2005, the Trident Submarine Outstanding Performance Award for 2003 and 2004 and numerous Departmental excellence awards.

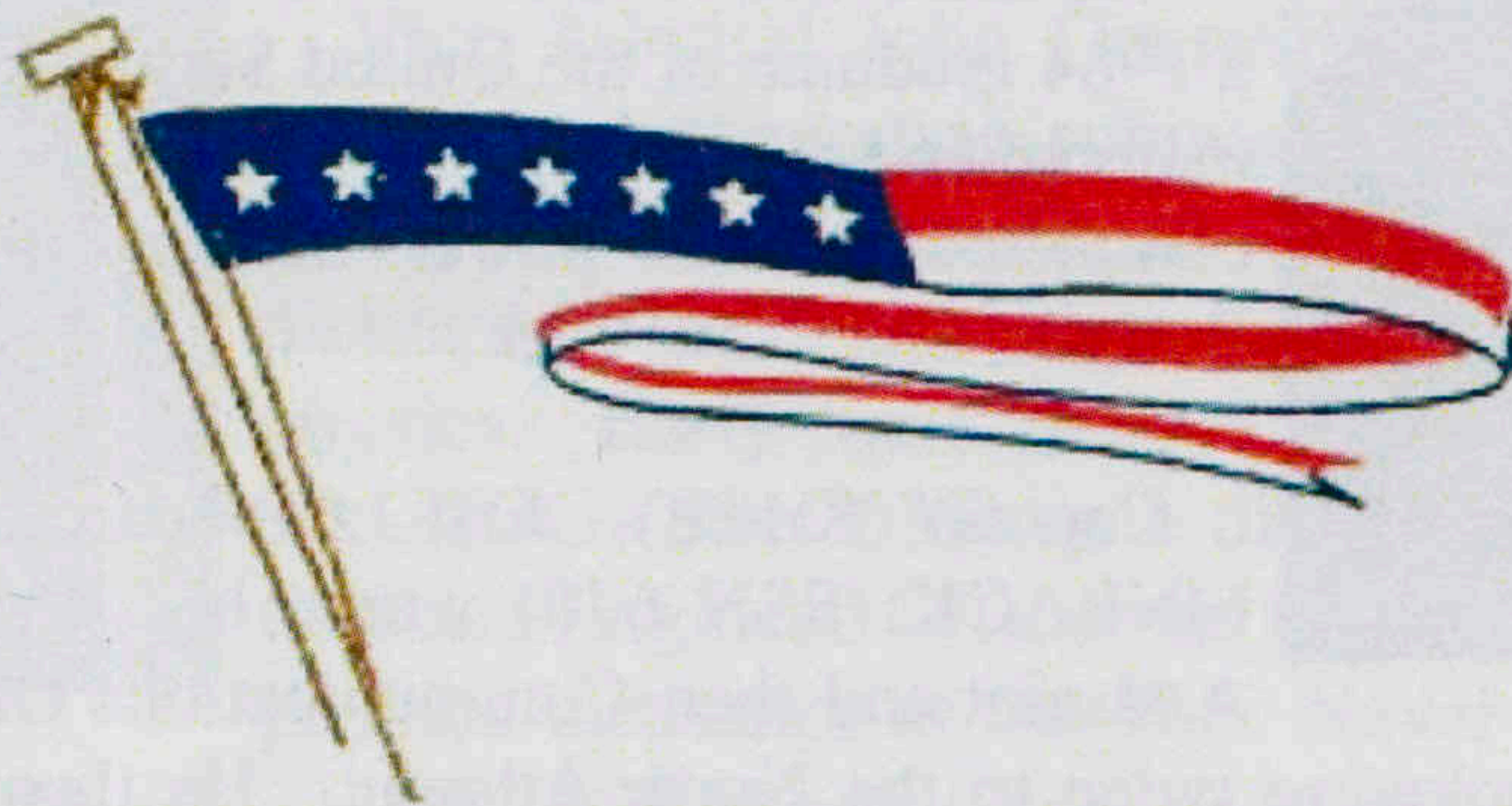
Following completion of Joint Professional Military Education, Captain Kriete served on the staff of Commander, Submarine Force, U.S. Atlantic Fleet as Senior Member of the Tactical Readiness Evaluation Team from July to September 2005 and then as Prospective Commanding Officer (PCO) Instructor from September 2005 to March 2007. During this time Captain Kriete trained more than 150 future submarine Commanding Officers and Executive Officers throughout six Submarine Command Courses (SCC). In April 2007, Captain Kriete assumed command of Submarine Squadron SIX in Norfolk, Virginia.

Captain Kriete's awards include the Legion of Merit (two awards), Defense Meritorious Service Medal, Navy and Marine Corps Commendation Medal (six awards), Navy and Marine Corps Achievement Medal (two awards), Navy Unit Commendation (two awards), Joint Meritorious Unit Commendation and Battle Efficiency "E" (five awards). He was named an Atlantic Fleet Finalist for the VADM James Bond Stockdale Leadership Award for 2003 and was designated a Joint Service Officer (JSO) in 2006.

Captain Kriete is married to the former Kathleen Coleman of Glastonbury CT. They have two boys, Matthew and Michael and reside in Chesapeake, Virginia.

THE COMMISSION PENNANT

At the moment the commission pennant is broken, a ship becomes the responsibility of the Commanding Officer, who, together with the ship's officers and men, has the duty of making her ready for any service required by our nation, whether at peace or at war.

The pennant has for centuries been the symbol of man-o-war. It is believed to date from the 17th century, when the Dutch were at war with the English. Dutch Admiral Maarten Harpertszoon Tromp hoisted a broom at the masthead to symbolize his intention to sweep the English from the sea. This gesture was answered by British Admiral William Blake, who hoisted a horsewhip indicating his intention to chastise the Dutch. The victorious British thus set the precedent for a long, narrow pennant to symbolize the original horsewhip as the distinctive symbol of a ship of war.

The modern U.S. Navy commission pennant is blue at the hoist with a union of seven white stars, and a horizontal red and white stripe at the fly.

THE INACTIVATION CEREMONY

The ceremony today is a tribute to the ship preparing for her decommissioning, the time-honored end of a ship's life. As decommissioning, the commission pennant is hauled down and the watches secured. The solemn ceremony where the commission pennant, ensign, and jack are hauled down for the last time is a dedication to the total operational success of the ship and the men who sailed it.

Ralph Schlichter
United States Navy
(Retired)**

Captain Ralph Schlichter graduated with distinction from the United States Naval Academy in 1964. Prior to serving as the commissioning Commanding Officer of the USS MINNEAPOLIS-SAINT PAUL (SSN 708), he served in USS CASIMIR PULASKI (SSBN 633)(BLUE) and (GOLD), USS ROBERT E. LEE (SSBN 601)(BLUE), and USS OMAHA (SSN 692) before commanding USS SCAMP (SSN 588).

Under his command, SCAMP completed a 20-month overhaul and circumnavigated South America during UNITAS XXII, and MINNEAPOLIS-SAINT PAUL was commissioned and completed shakedown.

Captain Schlichter later commanded USS McKEE (AS 41) for a two year tour that included deployment to the Persian Gulf during Operation Desert Storm/Desert Shield. Following this deployment, McKEE was awarded the Southwest Asia Service Medal with bronze star, the Battle Efficiency "E" and the Department of Defense Maintenance Award.

Captain Schlichter's shore assignments included tours on the Pacific Fleet Nuclear Power Examining Board; as Deputy Commander, Submarine Squadron TEN; as Nuclear Power and Submarine Enlisted Detailing Branch Head, Navy Military Personnel Command; as Chief of Staff, Submarine Group FIVE, and as the Deputy Director, Anti-Submarine Warfare/Undersea Technology at the Chief of Naval Research.

During his naval career, Captain Schlichter was awarded the Legion of Merit (three awards), the Meritorious Service Medal (two awards), the Navy Achievement Medal, the Meritorious Unit Commendation, and other personal, unit, and service awards.

Following retirement from the Navy in 1993, Captain Schlichter served for five years in managerial positions at the Brunswick Nuclear Station in Southport, North Carolina; and served for seven years as an independent nuclear engineering consultant in nuclear safety, license renewal, and other matters at the LaSalle County Station in Marseilles, Illinois, and at the Donald C. Cook Nuclear Plant in Bridgman, Michigan.

Captain Schlichter and his wife, the former Judith Riheldaffer Kuhn of Fort Pierce, FL, reside in Wilmington, North Carolina. They have five children – Sunny Callahan, Sally Eskridge, Dr. Susannah Aylesworth, Dr. Sander Schlichter, and 2LT Schuyler Schlichter, USMA 2006; and they have four granddaughters.



Rear Admiral Charles Beers United States Navy (Retired)

Rear Admiral Charles "Chuck" Beers was born in Summit, New Jersey, and enlisted in the U.S. Naval Reserve in 1962. He entered the U.S. Naval Academy, and graduated in 1967. Following nuclear power and submarine training, he reported to USS SKIPJACK (SSN 585), where he served as Supply Officer, Electrical Officer, Weapons Officer, and qualified in submarines.

In November, 1972, he reported to USS ABRAHAM LINCOLN (SSBN 602) (GOLD) and served as Engineer Officer. In January, 1976, he reported to USS HAMMERHEAD (SSN 663) where he served as Navigator and Operations Officer until May, 1978. He served as Executive Officer on USS MEMPHIS (SSN 691) from June, 1978 to August, 1981. He then reported to the staff of Commander Submarine Force, U.S. Atlantic Fleet in Norfolk, Virginia, and served as the Force Nuclear Power Officer from September, 1981 to December, 1983.

Rear Admiral Beers served as the Commanding Officer, USS MINNEAPOLIS-SAINT PAUL (SSN 708) from June, 1984 to June, 1987.

He returned to the staff of Commander Submarine Force, U.S. Atlantic Fleet as the Prospective Commanding Officer Instructor from June, 1987 to March, 1989. Following this tour, he relieved as Commanding Officer, USS DIXON (AS 37) home ported in San Diego, California, where he served until June, 1991.

From July, 1991 to August, 1993, Rear Admiral Beers served as the Deputy Director and then Director, Attack Submarine Division, in the Office of the Chief of Naval Operations. He served as Deputy Assistant Secretary for Military Application and Stockpile Support, U.S. Department of Energy, from September, 1993 to September, 1995. Rear Admiral Beers was Commander Submarine Group Ten in Kings Bay, Georgia from November, 1995 until his retirement in November, 1997.

Under his leadership, his crews have earned the Navy Unit Commendation, Meritorious Unit Commendation (Three awards), and the Battle Efficiency "E" (Five awards), the Navy Expeditionary Medal and the Navy Arctic Service Ribbon. His personal awards include; the Defense Distinguished Service Medal, the Legion of Merit (five awards), the Meritorious Service Medal (five awards), the Navy Commendation Medal (two awards), and the Navy Achievement Medal.

Rear Admiral Beers has attended Harvard University's John F. Kennedy School of Government and Massachusetts Institute of Technology Seminar XXI.

Rear Admiral Beers serves as Chairman of the Dolphin Scholarship Foundation. He is Vice President of the Hampton Roads Naval Museum and the Hampton Roads USO. He is serves on the Board of Directors of the Hampton Roads Navy League, and is a National Director of the Navy League.

Rear Admiral Beers is the Vice President, Maritime Programs and the Norfolk Field Office Manager at the Lockheed Martin Corporation's Norfolk Domestic Business Development Office. In this capacity he provides Corporate Field Marketing coverage to the important Maritime customers in the Norfolk area. He also chairs the Corporation's Maritime Focus Team, which is designed to bring the various corporate business units together and focus on complex Maritime programs/issues.

Rear Admiral Beers and his wife, Susan, have two children. Their son, Clay, is a 1995 graduate of the Naval Academy and an F/A-18 pilot. Their daughter, Irene, graduated from Colgate University in 1998 and is now a stay at home mom.



**Vice Admiral
James Metzger
United States Navy
(Retired)**

Vice Admiral James W. Metzger graduated from the U.S. Naval Academy in June 1971 and subsequently Michigan State University with a Master's Degree in Electrical Engineering. He attended Nuclear Power School in Bainbridge, Maryland and Prototype Training in Windsor, Connecticut.

Vice Admiral Metzger's initial sea tours include Electrical Engineering Officer and Main Propulsion Assistant aboard USS GEORGE BANCROFT (SSBN 643)(Gold), Engineering Officer aboard USS INDIANAPOLIS (SSN 697) which included the fleet transfer of Indianapolis to Pearl Harbor, and as Executive Officer aboard USS TAUTOG (SSN 639).

Vice Admiral Metzger's command tours include USS MINNEAPOLIS-SAINT PAUL (SSN 708), Submarine Development Squadron Twelve, Submarine Group Eight/Submarines Mediterranean, and the U.S. Seventh Fleet.

Significant shore and staff duty includes the staff of CINCPACFLT as a member of the Nuclear Propulsion Examining Board, and as Director, Prospective Commanding Officer School. Vice Admiral Metzger also served as Executive Assistant to the Commander in Chief, U.S. Atlantic Fleet, the Vice Chief of Naval Operations and the Secretary of the Navy, for whom he also served as Naval Aide. Vice Admiral Metzger also served as Deputy Director for Strategy and Policy, Joint Staff (J-5). He assumed assignment as Assistant to the Chairman of the Joint Chiefs of Staff on 22 July 2002, remaining in that position until his retirement on 1 January 2005. In that capacity, he traveled with the Secretary of State serving as his military liaison to the Joint Chiefs.

Vice Admiral Metzger's awards include the Defense Distinguished Service Medal, Distinguished Service Medal, Defense Superior Service Medal, Legion of Merit (with one silver star), Meritorious Service Medal (with two gold stars), Navy Commendation Medal (with two gold stars), Navy Achievement Medal, Navy Expeditionary Medal and Arctic Service Ribbon.



**Captain
Neil Rondorf
United States Navy
(Retired)**

Captain Rondorf was born in Thief River Falls, Minnesota, and graduated from Lincoln High School in 1970. He graduated from the United States Naval Academy with honors in 1974. Following graduation he completed Nuclear Power Training and Submarine School.

From 1975 until 1979, Captain Rondorf served as division officer on board USS ANDREW JACKSON (SSBN 619), participating in six strategic deterrent patrols. He was subsequently assigned as the commissioning crew Weapons Officer on USS INDIANAPOLIS (SSN 697). Upon completion of shakedown and certification, he was ordered to USS ROBERT E. LEE (SSBN 601) as Engineer Officer and completed the last Polaris missile patrol in the Pacific Theater. While serving as Navigator on board USS OMAHA (SSN 692) from 1981 to 1984, the ship completed two deployments to the Western Pacific and the initial 688 class submarine shock trials.

After serving as the Director, Enlisted Academics at the Naval Nuclear Power School from 1984 to 1986, Captain Rondorf was assigned as Executive Officer USS JACKSONVILLE (SSN 699). From 1987 to 1989 the ship completed two deployments, the first full-scale submarine shock trials in twenty years and commenced overhaul. In April 1990 he took command of USS MINNEAPOLIS-ST PAUL (SSN 708) and deployed to the Mediterranean Sea as the first submarine carrying Tomahawk missiles for use in Operation Desert Shield/Storm. The ship was awarded the Meritorious Unit Commendation for its contributions to the conflict.

From November 1992 to July 1994 Captain Rondorf was assigned as Deputy Commander, Submarine Squadron Three in San Diego. From April to July 1993 he commanded USS GURNARD (SSN 662), which was deployed to the Western Pacific. During his tour, Submarine Squadron Three was awarded the Meritorious Unit Commendation for developing submarine joint warfare concepts. From July 1994 to July 1996, he served in the Defense Liaison Division, Office of the Chief of Naval Operations, Washington, DC. In July 1996 Captain Rondorf became the Head, Undersea Surveillance (N874), Submarine Warfare Division on the staff of the Chief of Naval Operations.

Captain Rondorf assumed command of Commander, Undersea Surveillance on 12 August 1999 and retired from active duty on 1 October 2001.

Captain Rondorf is married to the former Cheryl Anne Kruse of Sparta, New Jersey. They presently reside in Virginia Beach, with their three children Ryan, Kira and Kevin. Their son Sean is a Combat Engineer with the 82nd Airborne at Ft Bragg.

(Retired)**

Captain Michael Agor graduated with honors from the United States Naval Academy in 1976 with a Bachelor of Science degree in Mathematics. He attended Nuclear Power training in Orlando, Florida and the S5G prototype in Idaho Falls, Indiana.

In March 1978, Captain Agor reported aboard USS ULYSSES S. GRANT (SSBN 631) (GOLD) and completed two strategic deterrent patrols. Next he attended the Naval Postgraduate School in Monterey, California under an Admiral Arleigh Burke scholarship, graduating with honors with a Master of Science degree in Operations Research in October 1982. After completing the Submarine Officer Advanced Course in March 1983, Captain Agor served as Engineer Officer onboard USS BLUEFISH (SSN 675) during which time the ship completed several North Atlantic and Mediterranean deployments.

He then served as a member of the Nuclear Propulsion Examining Board on the staff of Commander in Chief U.S. Atlantic Fleet from July 1986 to July 1988. From July 1988 to January 1989 he attended the Armed Forces Staff College, Norfolk, Virginia. Captain David Ratte United States Navy

During this tour, he served as Chemistry and Radiological

USS MINNEAPOLIS-SAINT PAUL (SSN 708), a Los Angeles-Class Submarine, was the first vessel of the United States Navy to be named for the metropolitan area of Minneapolis-Saint Paul, Minnesota, although each city had been honored twice before. The contract to build her was awarded to the Electric Boat Division of General Dynamics Corporation in Groton, Connecticut on 31 October 1973 and her keel was laid down on 20 January 1981. She was launched on 10 March 1983 sponsored by Mrs. Penny Durenberger (Wife of Senator David Durenberg), and Commissioned on 10 March 1984, with Commander Ralph Schlichter in command.

The previous St. Paul (CA-73), was the last big gun heavy-cruiser in the United States Navy, and held the distinction of having fired the final shot of World War Two.
